#### Our work to date

As a result of our targeted public affairs and PR strategies, we have:

Ensured that TDRs are not classified as medical foods, avoiding a stricter regulatory framework for the programmes.

Made sure that MRPs are regulated under general food law & worked to ensure that all the additives currently authorised in MRPs are still in place, despite changes in their classification under the Additives Regulation.

Secured an exemption for TDRs and MRPs from UK restrictions on the promotion and advertising of foods high in fat, salt and sugar (HFSS).

Met with numerous policymakers to bring awareness of the role of TDRs & MRPs in tackling obesity rates in Europe.

Ensured fit-for-purpose legislation for TDRs, obtaining the inclusion of a transition period in the 2017 Delegated Act on TDRs composition and labelling requirements and, more recently, the revision of magnesium and essential fatty acids requirements to bring them in line with the latest scientific

evidence.

Organised well praised webinars and events attended by regulators, policymakers, academics, physicians and industry stakeholders, to educate them about the crucial role of TDRs and MRPs in tackling obesity.

Did you know that the slimming foods sector is facing a challenging period from a regulatory perspective? Among others, the front-of-pack nutrition labelling (FOPNL) and nutrient profiles legislation that the European Commission is working on risk unfairly impacting the industry unless clear exemptions are introduced for TDRs and MRPs. Meanwhile the UK is working on a review of the regulatory framework for TDRs which may lead to a change in the composition and labelling requirements for these products.
